### **Commemoration of the 20th Anniversary of the World Summit for Social Development**

At the panel to commemorate the 20th anniversary of the World summit for Social Development, Social Watch coordinator Roberto Bissio said that "as we advance into the post-2015 agenda, some key ideas endorsed by the Social Summit are being reaffirmed. Inequalities are back in the agenda, after having disappeared for 15 years, and universality is recovered, with a strong sense of social protection floor. It is urgent, though, to make serious progress in the implementation of those agreed aspirations. Inequalities are in the title of a goal but nowhere to be found on the proposed indicators and a clear financing commitment on social protection floors (cash transfers/benefits for children, for people of working age in cases of maternity, unemployment, disability or work injury, and pensions for older persons, and other schemes) is still missing, even when now as in 1995, the resources are there."

#### SDGs: Goals and targets left behind

This table was compiled by Social Watch from quotes of the Sustainable Development Goals as proposed by the Open Working Group and endorsed by the UN General Assembly as the basis for the new development agenda and the "First proposed priority indicator list" compiled by UNSD in preparation of the first meeting of the Inter-Agency Expert Group on SDGs, New York, June 1 and 2, 2015.

### Lost in indicators: How the "experts" are rewriting the SDGs

Almost one third of the targets that define the 17 Sustainable Development Goals approved by the governments at the UN are being de facto rewritten or deleted by the Inter-Agency Expert Group proposal of "priority indicators" published June 1 in New York. Important notions included in the SDGs such as labour rights, women rights to property, financial services, inheritance and natural resources and many commitments of developed countries to support the efforts of developing countries are excluded from the proposed list of indicators and would therefore not form part of the UN reviews of the new development agenda. *by Roberto Bissio, Social Watch*

# Private investment dominates, systemic issues ignored as EU Ministers discuss the future of development finance

EU Ministers met on May 26 to finalise the EU's position ahead of the crucial UN Financing for Development (FFD) summit in Addis Ababa. The EU position reveals that the Ministers prefer to promote a controversial and problematic reliance on private finance rather than tackling crucial systemic issues such as the need for global tax reform. Other issues addressed during the meeting were the existing aid commitments as well as tax justice. However, according to the head of Tax Justice and Financing for Development at Eurodad, Tove Ryding, there is a very real risk that the international negotiations will collapse if the EU Ministers don't become more ambitious.

# Regulatory framework fails to match hope placed on private companies, new studies say



Negotiations towards the Third International Conference on Financing for Development, to be held in Addis Ababa (Ethiopia) on July 13-16, are in full gear. In line with ongoing trends in the landscape of development assistance, deliberations thus far have shown a strong promotion, especially by Northern countries, of increased reliance on private sector sources for development funding. Two new studies set out to interrogate what does this mean for the language on human rights accountability of the private sector that we should expect to see negotiated in the conference, and whether expectations are being met by reality.

## INGOs in Haiti: Development Actors as agents for Alternatives to Development?



NGOs, particularly those seeking to imagine and practice alternatives, are confronted with the pitfalls of this aspiration and the reality of being a part of the structured mainstream development apparatus. Very little practical research has been conducted so far, both about the consequences for their work, as well as conflicts within Post-Development theory itself. Indeed, although Post-Development has been discussed extensively on a theoretical level

and been criticized for lacking propositions of concrete and constructive alternatives, spaces for a practical Post-Development implementation have yet to be explored. In this discussion Julia Schoeneberg aims to investigate what practical contribution Post-Development has to offer for progressive development work. The focus of her paper is laid on partnerships and cooperation between Haitian and international NGOs.

#### The current tax system is broken and needs reform



The recently published declaration by ICRICT (Independent Commission for the Reform of International Corporate Taxation) argues that the current tax system has become obsolete as a result of globalization and the changing world economy. ICRICT states that an adjustment of the tax system is indispensable and that the efforts by OECD are not sufficient. The commission therefore aims to push governments around the world to take action. The declaration presents a set of principles and recommendations for

reform. One key recommendation is to abolish the separate entity principle which is considered to be the fundamental problem of the current tax system. ICRICT recommends to treat multinational corporations as single and unified firms and to divide the taxable profits between the countries where the income generating activities are located.

# G7 food initiative driving hunger in African countries, say global civil society groups



Politicians and executives from some of the world's biggest agribusiness companies are meeting in Cape Town, South Africa, on June 3, 2015, for the leadership council of the controversial New Alliance for Food Security and Nutrition. On the same day, a coalition of a hundred farmers' organisations, social movements, unions and civil society groups around the

world have released a statement calling on the G7 and African governments to stop supporting the New Alliance. The policies of the New Alliance have been criticised as they "facilitate the grabbing of land and other natural resources, further marginalize small-scale producers, and undermine the right to adequate food and nutrition."

### New Call for an International Legal Framework on Business and Human Rights



In June 2014, the UN Human Rights Council adopted Resolution 26/9 to establish an Intergovernmental Working Group (IGWG) whose mandate shall be to elaborate an international legally-binding instrument to regulate the activities of transnational corporations and other business

enterprises with respect to human rights. Ahead of the upcoming first session of the IGWG on 6-10 July 2015, the Treaty Alliance, a coalition of more than 610 NGOs and 400 individuals across the globe, calls on all civil society organizations and States to actively and constructively participate in this process. The new Treaty Alliance joint statement calls for signatures to demand strong regulation of corporate human rights abuses, new strong systems of remedy for affected people and no undue corporate interference in the treaty-making process.

#### Money Talks: Africa at the G7



At their forthcoming summit in Germany, G7 leaders will meet some of their African counterparts to discuss how they can support economic growth and sustainable development in Africa. According to a recent report published by Oxfam International, the continent has enjoyed a recent economic boom but the rich world is reaping the rewards of this growth, as billions of dollars a year flow out of Africa. This is depriving it of vital revenue that could enable it to fund healthcare and

education for all, and invest at scale in sustainable agriculture. The report states that in 2010 alone, G7-based companies and investors cheated Africa out of an estimated \$US6bn through just one form of tax dodging —trade mispricing.

#### Responsibilities beyond borders: unlocking the post-2015 stalemate on international cooperation



As the UN holds two seminal, simultaneous meetings this week to determine the future of the post-2015 and the financing for development (FfD) agendas, the Center for Economic and Social Rights and Third World Network are launching a new briefing which argues that human rights obligations can provide a fresh lens on one of the most entrenched stalemates in the negotiations: the respective responsibilities of governments North and South to achieve and to finance the Sustainable Development Goals (SDGs).

### **Indigenous Peoples Right to Free, Prior and Informed Consent: The Peruvian case**



The right of indigenous peoples to free, prior, and informed consent in relation to development, infrastructure, and resource extraction projects is critical to the realization of all indigenous rights connected to the preservation and control of their territories. In a legal argument regarding this right, Mónica Yriart, an attorney in constitutional law, human

rights and the rights of indigenous peoples, asserts that national political powers have no intention of conceding the right of consent to indigenous peoples, and that it is now essential to trace a carefully planned, and well timed strategy, from the first step to the last, and to "accept no failure." Especially in the light of the current conflicts around the Tía María mining project and the plans of 20 hydroelectric dams on the Marañón River in Peru, the right of indigenous peoples to free, prior and informed consent is of vital importance.

### WHO: Work on non-State actors engagement framework to continue



The recently concluded 68th World Health Assembly (WHA) adopted a resolution to continue negotiations on WHO's Framework for Engagement with Non-State Actors. The seven days of hectic negotiation, which started on 20 May could not reach consensus on critical issues due to the divergence of

views among Member States. These issues include the definition of resources, secondments, the relation of WHO with industries other than the tobacco and arms industry, transparency requirements, oversight mechanism of engagements with non-State actors (NSAs), ceiling on financial resources, and others. The advocates for enhanced engagement with NSAs are developed countries and this was viewed by developing countries as an attempt to facilitate corporate capture of the WHO.

#### The Third FFD Conference Follow-up



As governments negotiate the Third Financing for Development Conference (FFD 3) to be held in Addis Ababa (13-16 July 2015), an important decision that they will have to make refers to the follow-up process. This brief piece by CIDSE offers some thoughts on the international dimensions of such monitoring, accountability and review mechanisms. The briefing note elucidates that the FFD follow-up process has two roles to fulfill: it should serve as a coordination forum for tracking progress on all sources of finance for development, and secondly it should support the SDGs. Nevertheless the paper points out why it is crucial that the FFD follow-up process needs to be separate and autonomous

from the Post-2015 agenda.
